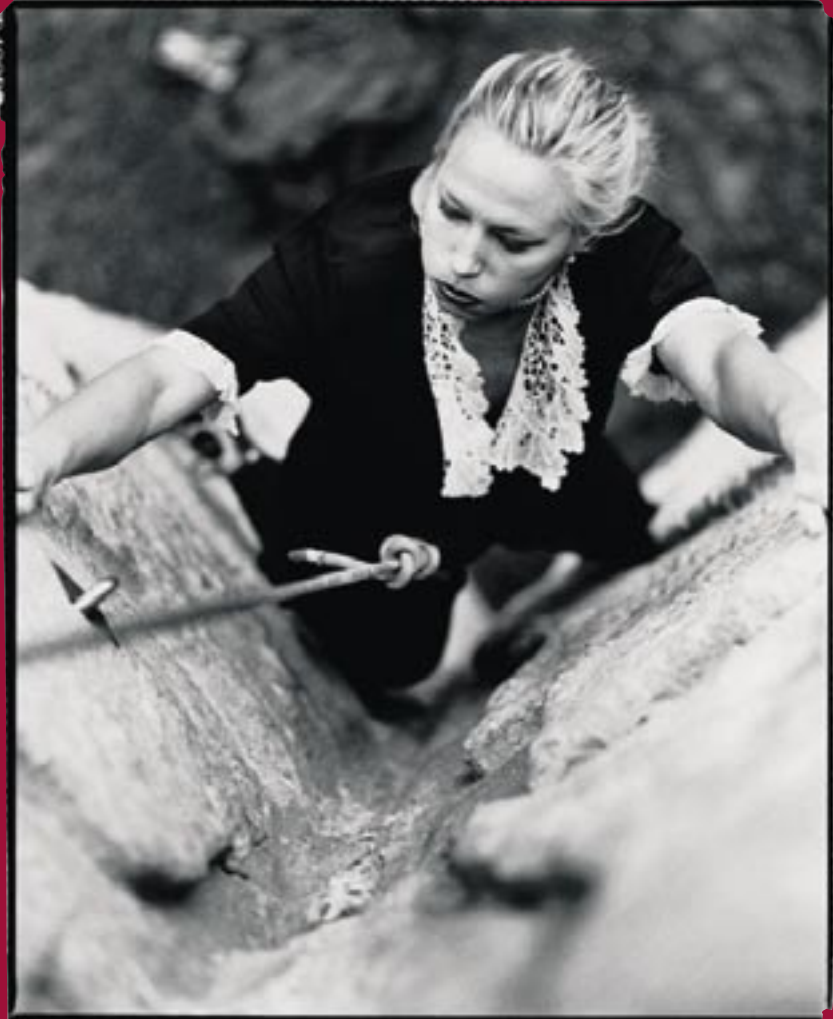

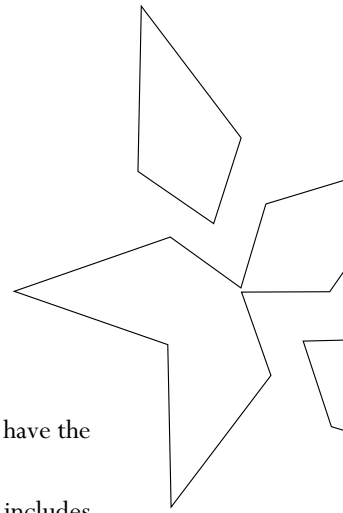

~ FORENSIC ACCOUNTING ~

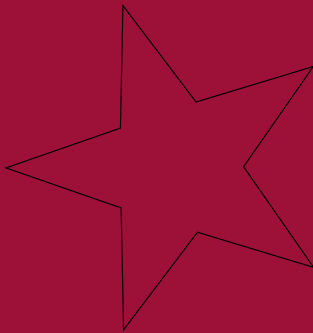
